2. Reports

<u>President</u>

Hockey Season 2020/21 was a new experience for everyone involved, and I cannot express enough how grateful I am for the cooperation of the executive, volunteers, and membership in general for keeping an open attitude, and remaining flexible throughout. Our philosophy for this season was to ensure that we were able to provide the players an affordable and fun hockey season. We aimed to keep them engaged in sport, and provide a semblance of normal when so much in their daily routine was not. This was done all in the hopes that they return the following year.

As such, several decisions were made:

- Reduced fees to reflect no tournament grants, less referee costs, and a shorter season.
- Bubble within DRAMHA only to avoid having to travel outside of Deep River.
- Collapse the U15 age group given such low numbers and disperse players to either U13 or U18, in consultation with parents and coaches.

With the abrupt end to the season, the executive made the decision to not issue refunds, but to take into account the abbreviated season for returning players next year. Exceptions were made for graduating players, and no other requests for exceptions were made.

We should be incredibly proud that we were able to provide a hockey environment that was fun for our kids, but more importantly, covid safe. We were able to run the season without any major concerns at all. That is a credit to all involved. ONce again we enjoyed the support of the Town of Deep River, with special mention to Eric McQuestion and his staff.

Should I be re-elected, I look forward to continuing to serve Deep River and Area's Minor Hockey's interests.
